<p><b>Partner</b></p>	<p><b>General Council of Gers (Conseil Général du Gers), France</b>  <i>(local public authority)</i></p> <p>The General Council is in charge of the administrative and social protection of children at risk in the Gers department. The Council works notably in collaboration with residential care settings dedicated to children with no or insufficient parental care, and thus needing alternative care.</p>
<p><b>Outline and objectives of the partner search</b></p>	<p>The General Council of Gers initiated in 2014 through its Child and Family Department the organisation of artistic expression and pedagogic workshops focusing on the promotion of child rights.</p> <p>These workshops organised for children placed under child protection aimed to create innovative awareness-raising methods and materials, while fostering expression of this young audience. These workshops will be repeated in 2015, in particular in the residential care settings affiliated to the General Council, and they obtained a French label from the national administrative entity “Defender of Rights”.</p> <p>The General Council would appreciate having the opportunity, as a way to further this approach, to share with other child protection stakeholders on these practices. The Council could, as a participant in a cooperation and mutual learning project on fight against bullying, share its experience gained thanks to the organisation of these workshops.</p>
<p><b>Profile of partners sought</b></p>	<p>Public or private organisations active in the field of child protection and working in collaboration with residential care settings, if possible from Member States with a socioeconomic context comparable to the French one.</p> <p>The General Council would like to join as a partner an existing or developing consortium.</p>
